Tämä esikäsitteily neste on kehitetty käytettäväksi erityisesti UltraChrome DG -musteen kanssa. Se on välttämätön tulostettaessa suoraan mustille tai tummille kankaalle, jotta voidaan varmistaa laadullisesti paras lopputulos.

Neste on tiivistettä, jota pitää ohentaa veden kanssa suhteessa 1:1-1:3 (esikäsitteily nestettä suhteessa veteen). Kun neste on ohennettu, sitä voidaan käyttää suoraan kankaalle ennen tulostusta.

Epson suosittelee vain aitojen Epsonin esikäsitteily nesteiden käyttöä, koska muiden tuotteiden käyttö voi vaikuttaa tulosteiden laatuun.
