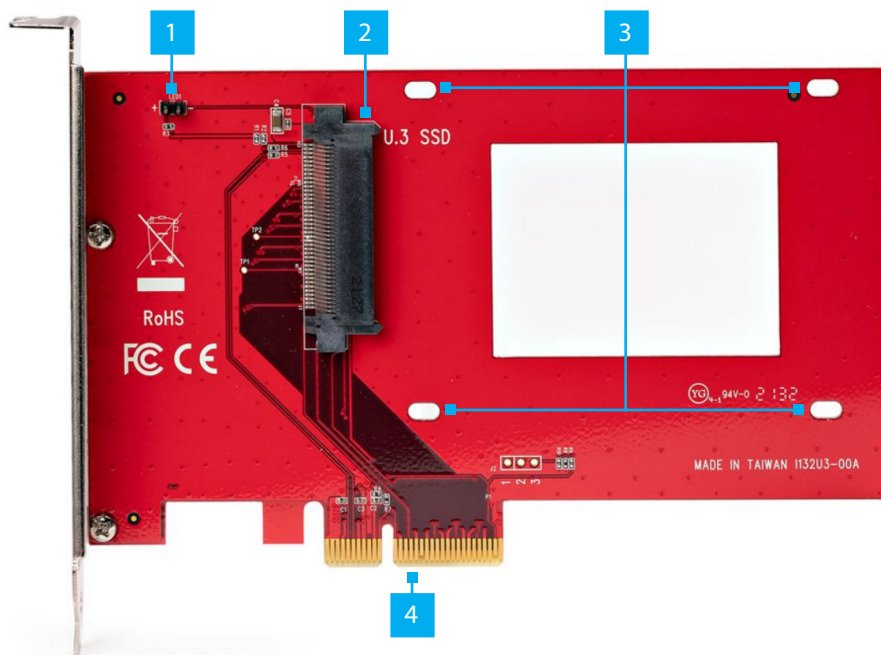

Installation

Connect an SSD to the Drive Adapter

Warning! Drives should be handled carefully, especially when being transported. If not handled with care, lost or corrupted data may be experienced. Ensure that the **Installer** is properly grounded before opening the **Computer Case** or touching the **U.3 to PCIe x4 Adapter**. The **Installer** should wear an **Anti-Static Strap** when installing any computer component. If an **Anti-Static Strap** is not available, discharge any built-up static electricity by touching a large **Grounded Metal Surface** for several seconds. Only handle the **U.3 to PCIe x4 Adapter** by its edges and do not touch the gold connectors.

1. Carefully slide the SSD into the U.3 to PCIe x4 Adapter and connect it to the U.3 (SFF-TA-1001) Connector on the card.
2. Turn over the U.3 to PCIe x4 Adapter.
3. Use a Phillips Screwdriver and insert the four Drive Mounting Screws through the Drive Mounting Holes on the U.3 to PCIe x4 Adapter and into the SSD.
4. Tighten the Screws to secure the drive to the U.3 to PCIe x4 Adapter.

Installing the Drive Adapter

1. Turn off the Computer and any connected Devices or Peripherals (such as printers and external storage).
2. Unplug the Power Cable from the back of the Computer.
3. Disconnect any Peripheral Devices connected to the Computer.
4. Open the Computer Case, referring to the documentation that came with the computer system for guidance.

5. Locate an available **PCIe x4 Slot** and remove the corresponding **Metal Cover Plate** from the back of the **Computer Case**. Refer to the documentation that came with the **Computer System** for detailed instructions on how to do this.
6. Gently insert the **U.3 to PCIe x4 Adapter** into the available **PCIe Slot** and use a **Computer Case Screw** (not included) to secure the bracket to the back of the case.
7. Replace the cover on the **Computer Case**.
8. Reconnect the **Power Cable** to the back of the **Computer** and reconnect all **Peripheral Devices** that were disconnected in **Step 3**.
9. Turn on the **Computer** and the connected **Peripheral Devices**.

Note: The **U.3 to PCIe Adapter** is compatible with **x4, x8, or x16 PCIe slots**.

Note: In the event that the drive is new or does not already contain data, it may be necessary to initialize the drive. For instructions on how to complete this process, please refer to the documentation of the operating system installed on the computer.

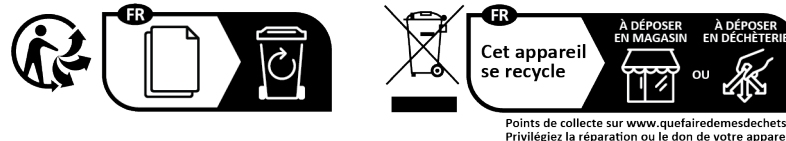
